

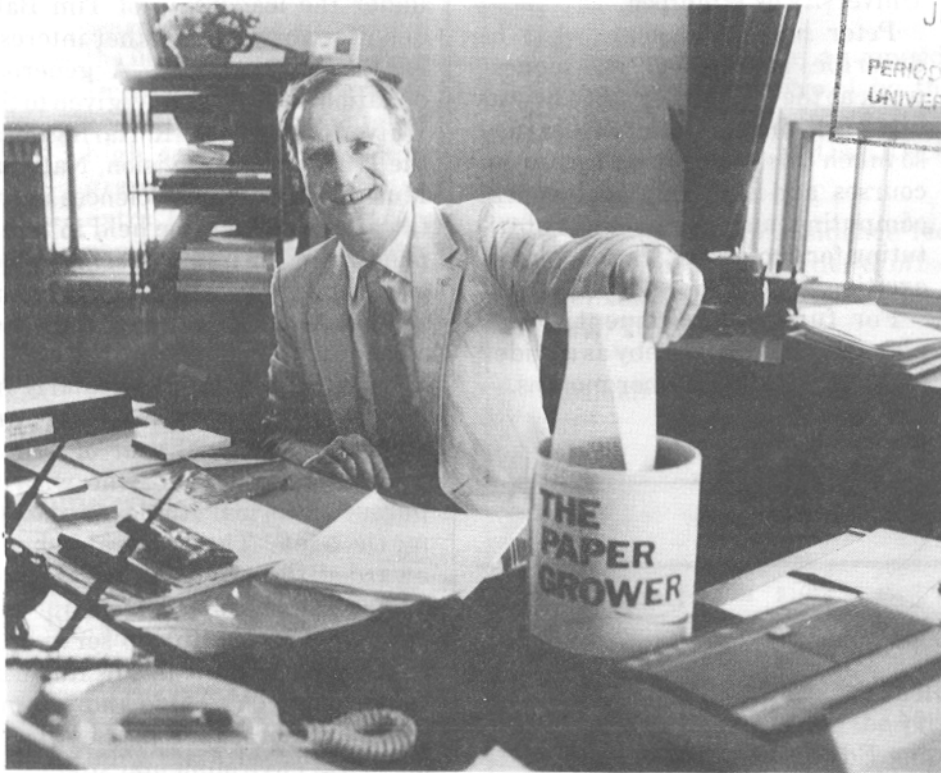

Paper Project Kick-Off in President's Office

The Paper Project (the University's pilot project in office paper recycling) kicked off its campaign to collect high-grade waste paper with the distribution of "paper growers" in the administrative offices of Wesley Hall's third and fourth floors and the Registrar's Office on Friday, May 16. Collection at the desk-top level facilitates the separation of high-grade recyclable paper from the waste stream. This separation at source is central to the success of the recycling program. Judging by the response of those already involved, the project staff feels it can look forward to a high level of participation from faculty and staff, and expects to see "paper growers" in use throughout the University by the beginning of the new academic year.

Last month Willpax Ltd. purchased its first load of paper for recycling from the University. Nearly three quarters of a ton of paper was gathered by the project from Printing Services, the Computer centres, the collection of old exams, and contributions made by individuals. The project also arranges for the collection of newspapers by Goodwill Industries and has already disposed of about 600 pounds of newsprint in this way. The University's response to the project's efforts in collecting computer print-out paper, newsprint, and re-usable scrap paper has been encouraging, and it is hoped that the "paper growers" will generate equal enthusiasm. Faculty/Staff Activity

Jewel K. Reimer, Assistant to the Vice-President (Academic), participated in the Annual General Meeting of CAURA (Canadian Association of University Research Administrators), May 11-13, 1986. University of Winnipeg student Robert Rostecki captured first place in the 1986 Manitoba Mathematical Contest. Last year, Robert was the top Manitoba entrant in the University of Waterloo Mathematical Contest, and placed seventh among his national competitors.

Fellowship Established

Funding for a new fellowship has been received by the University to support the future research activities of the Rupert's Land Research Centre, currently being developed under the leadership of Tim Ball, Jennifer Brown, and other interested faculty members. A generous donation of \$20,000. was given to the University by Dr. C.R. Harington of the Paleobiology Division, National Museum of Natural Sciences in Ottawa. His gift will be held in trust, pending a formal agreement between the University and him on the conditions for awarding the fellowship.

Dr. Harington is particularly interested in helping students who are entering their final year of undergraduate studies and who wish to pursue historical studies in the climatic area. The student who is awarded the proposed new annual \$1000 Harington Fellowship will have a responsibility to serve as a part-time assistant in the Rupert's Land Research Centre and to complete a major paper in the area of historical environmental studies.

Board Highlights from the Meeting of April 28, 1986

President's Report

In reviewing his report, Dr. Farquhar noted several points:-

- the success of faculty and students in obtaining NSERC research grants and scholarships
- the introduction by the French Department of programs to accommodate students from high school immersion programs
- extra funding to be received as part of the inter-university Nursing Program
- plagiarism problems, especially with foreign students
- the United Church conference to be held on campus for the first time.

Committee Reports

Finance

Mr. MacDonald reported that the committee recommended the acquisition of the remaining two properties in the north end of the block containing the Athletic Centre. The total cost was expected to be about \$100,000 which would be provided from Unrestricted Trust Funds.

It was therefore moved (J. MacDonald/Purves) that:-

the administration be authorized to purchase the properties at 375 and 391 Young Street, with the funding to be provided from Unrestricted Trust Funds.

... CARRIED

The committee also recommended the creation of an Audit Committee as a standing committee of the Board. This proposal would necessitate an amendment to Bylaw No. 1 for which notice was required.

It was moved (J. MacDonald/Purves) that:-

- i) an Audit Committee be established as a standing committee

tee of the Board of Regents with the terms of reference and membership as described in the proposed Article 14A dated 21 April, 1986, a copy of which forms part of these minutes and

- ii) notice be given of an amendment to Bylaw No. 1 by the insertion of Article 14A.

A 4% increase in residence fees was recommended in order to offset higher costs. It was moved (J. MacDonald/Thompson) that:-

The Committee had reviewed and recommended approval of the 1986-87 budget for Ancillary Services and for the Institute of Urban Studies.

It was moved (J. MacDonald/Thompson) that:-

the 1986-87 Operating budget for Ancillary Services, dated 17 April, 1986, be approved.

It was moved (J. MacDonald/Candlish) that:-

the 1986-87 operating budget for the Institute of Urban Studies, dated 20 March, 1986, be approved.

... CARRIED

Institute of Urban Studies

Dr. Candlish questioned the rationale for the I.U.S. Board, if I.U.S. was to be treated more like other

University units and its budget was to be reviewed by the Finance Committee. The I.U.S. Board had been originally set up to supervise its finances.

The Advisory Committee of I.U.S. would still continue, but she felt that the I.U.S. Board was now redundant. She therefore gave notice of motion that at the next meeting an amendment would be proposed to Bylaw No. 1 deleting Article 20 thus dissolving the I.U.S. Board.

Planning

Dr. Farquhar explained that there were presently several different planning activities being undertaken within the University. Among the more important of these were the 10-year development plans of the Faculties and the Library, the Fund-Raising Campaign planning and the Facilities Development plan. Now was the time to integrate these various thrusts in an overall planning process in which there should also be some input from lay members of the Board.

His memorandum of 14 April outlined the Strategic Planning schedule with the final document going to both Senate and the Board for approval.

At this point Dr. Kahn questioned the apparent distinction between lay and other members of the Board with regard to their prospective contributions to the planning process. In the ensuing discussion, it was recognized that all members served for the general good of the University and not for any particular constituencies and that individual experience and expertise rather than type of appointment would normally make a better criterion in selection for tasks.

It was then moved (Purves/Thompson) that:-

- i) the Board give its approval to the strategic Planning schedule of 14 April, 1986 and

- ii) an ad hoc Planning Committee of the Board be formed, with members to be appointed by the Nominating Committee, to assist in the development of the strategic Planning document. ... CARRIED

Other Business

Dr. Candlish questioned the purpose of the Board's Committee on Student Affairs since it had never yet met. Dr. Farquhar pointed out that should any decision of the Senate concerning students be appealed to the Board, the matter would be referred to this committee. In addition, the Board might also refer other issues to it.

Finance Committee

The President's operating budget recommendations for 1986/87 include allocations of the redressment grant to be used for capital development projects for purposes of academic improvement as well as the

establishment of a writing skills program. Contained within the report is a reorganization of personnel administration and the Registrar's Office.

The President's recommendations were approved by the Board; the complete text of these recommendations is inserted in this issue of "In Edition".

1986-87 Operating Budget Recommendations

The Committee reviewed Dr. Farquhar's proposals in some detail and recommends to the Board that:-

Investment Policy

The Pension Investment Sub-Committee in conjunction with the new investment manager, Jarislawsky, Fraser & Co. Ltd., has developed investment objectives and guidelines

The University of Winnipeg invites nominations and applications for the position of Vice-President (Administration)

The incumbent of this position will be responsible to the President for supervising the managers and functions of the Controller's Office, Maintenance Department, Computer Services, Employee Relations, Athletics and Recreation, ancillary operations, and various support services. In particular, he or she will personally provide leadership in the areas of financial planning and capital development. Appointment to this position will be subject to review at least every five years.

The University of Winnipeg is a primarily undergraduate, liberal arts institution which is located in downtown Winnipeg. Enrolment is comprised of approximately 7,500 full-time and part-time university students and 600 senior Collegiate students, and the University employs about 500 regular faculty and staff members. There are two Vice-Presidencies, the other being Vice-President (Academic).

This appointment will commence on January 1, 1987, or as soon thereafter as possible and the salary is dependent on qualifications.

Psychology Research Conference

Psychology students from four Prairie universities participated in the Psychology Undergraduate Research Conference here on May 3. Ninety persons registered for the one-day event and the 35 presentations included papers by students from the universities of Winnipeg, Manitoba, Brandon and Saskatchewan.

Now in its fifth year, the annual conference provides senior students in the University of Winnipeg Psychology program with an opportunity to present their research findings in public and to host colleagues from other universities.

After lunch, Dr. Elinor Ames, past president of the Canadian Psychological Association and associate professor at Simon Fraser University, addressed the increasing diversity in the field of psychology in a talk on the question, "Who and What are Psychologists?" While it is increasingly difficult to define psychologists by what they do or where they work, she argued, the field is

united by "a certain habit of thought . . . Psychologists are educated to ask appropriate questions and to go about finding answers."

In an interview later, Dr. Ames offered high praise to the Psychology Department at the University of Winnipeg for providing undergraduate students with the opportunity to report on their work and for the excellent quality of the research being conducted by its students. "This conference demonstrates to students that science — in this case, psychology — is done in a social community. To finish off your research, you must present your work to colleagues."

"An excellent turnout and a very successful day", commented departmental chairperson Dr. Ron Norton in summing up the event. He noted the special contribution of Dr. Katherine Schultz, who has been the prime mover behind the annual conference since it began in 1981.

CISCAP

(Computerized Inventory of Statistics Canada Publications)

During the 1985/86 academic term, University of Winnipeg reference librarians collaborated with four business computing students to design a software program that would provide better subject access to and simpler inventory control over the Library's Statistics Canada holdings.

Sorted according to their content, the holdings are placed in the reference stacks, the periodicals department, or stored in metal filing cabinets. With various retention periods and locations of items, it has been necessary to enter a complicated series of notations into the Statistics Canada annual catalogue. To simplify matters, a data base management program was devised entitled CISCAP (Computerized Inventory of Statistics Canada Publications). CISCAP was written in dBASE II and was designed to operate on a

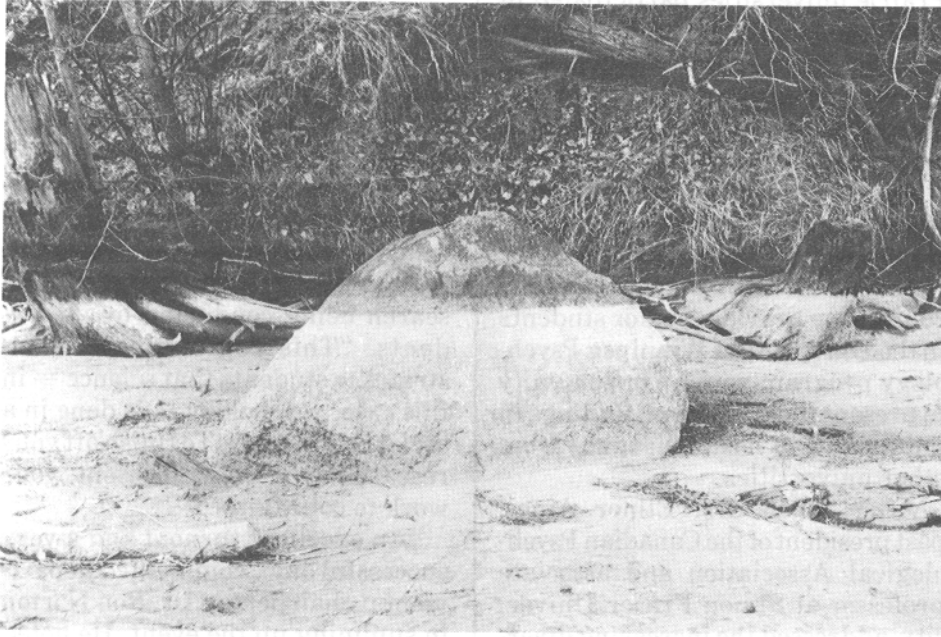
DEC 100 microcomputer with at least two disk drives. Each record in the data base contains space for the StatsCanada number, title, Library call number, holdings or retention information, former title, and additional subject terms.

While data entry is still in progress, the system appears to be working well. Plans to enter the 1981 and 1986 Census publications onto separate diskettes are in progress.

Software for CISCAP was designed by Professor Peterkin and students Lee Man Pun, Peggy Dang, Miranda Siu, and Isabelle Vannini. Linwood DeLong of the Library Reference Department will demonstrate the system to interested persons.

Peace Directives: A Portfolio of Photographs by Bruce Hanks

Atmosphere of Wisdom

More and more, photographers seem to be saying that things are not what they seem. One branch of this thinking views photographs as fictions, not so much evidence of the thing caught at a passing moment in time as much as the thing created for all time — photography not as journalism but as art.

Another approach feels that the world is a mystical place, the essential character of which is obscured by the hustle and fussiness of life. The photographer's role, then, is to reveal the deeper patterns of coherence in nature and, to no less an extent, in society.

Bruce Hanks is in this latter camp, but he adds to it a decidedly religious character. A practising Baha'i for seventeen years, he is constantly on the lookout for signs of immanence and order in the world, for the ways in which single objects — a fallen roadsign, a rock, a wheelbarrow, a post — indicate intelligence in the making and in the operating of the everyday world.

The release in November, 1985 of a statement on peace by the Universal House of Justice (the elected governing body of the Baha'i international community) caused Hanks to consider how best he might communicate the principles of unity and

wholeness in human relationships that are central to the Baha'i faith. He went back to a collection of photographs he had taken over a two year period and found in them a focus for "this fundamental principle of unity".

Hanks clearly perceives in found and inanimate objects an opportunity for us to locate and reflect upon the peace within ourselves. The photographs in this portfolio (which are selected from a much larger body of work) are not unique in their technical accomplishment, or even in their sense of composition. They are characterized by an ingenuousness and a simplicity that is by and large, innocent. They also underlie a recognition that in the most innocuous object or location we can find not only beauty, but a symbol of our best, inner selves.

In *Atmosphere of Wisdom*, for example, the rock stained by a high water mark seems so insubstantial as to be almost not present in the foreground of the image. It convinces us not so much that it has been under water as that it has had an existence *beyond* the physical. It is in this suggestive sense that Hanks' photographs are metaphysical.

The insistent pull in this work is

towards wholeness and completion, so that *Urge Towards Unity* shows us some sections of underground plastic tubing that seem to be arranging themselves into something recognizable. It's as if a pair of synthetic snakes were being charmed, or charming themselves, out of chaos. This world is full of meaning, whether in the phoenix-like luminosity of a pile of burning leaves, in the overgrown obscurity of a toppled roadsign, or in the dark presence of a wheelbarrow humanizing a cemetery that is criss-crossed with cooling shadows.

Occasionally, there is a homely abstraction about these photographs and the objects contained within them, although the most abstract note is sounded in the titles for the images themselves, all of which have been gleaned from either the peace statement or from assorted Baha'i texts

But then all hell breaks loose. In *Universal Framework* the playfull collapse of rafters and plastic hangings is an astonishment. It's as if Ariel, hot out of Shakespeare's *Tempest*, were a recalcitrant child who hadn't cleaned up the mess in her natural room; or as if light had gone for a hectic constitutional and left its tracks suspended in space. Or what is the wonderful question posed by Gerard Manley Hopkins, the great poet and convert to the Jesuit's version of the world, in "Pied Beauty": Glory be to God for dappled things"?

Peace Directives, too, is dappled, recognizing and leading us towards the play of light in shadow that is the stuff out of which human dreams and nightmares are continually made.

A revised employee booklet will now be prepared based on the revised plan text, for distribution to all members. The new investment arrangements will also be described in a letter to the plan membership. In addition, the Benefits Administrator is planning to meet with departments in order to explain the pension plan and other benefits.

The Committee wishes to report that 395 and 391 Young Street have been purchased by the University, thereby consolidating property hold-

ings on Young Street between the Athletic Centre and the C.B.C.

Relocation and Consolidation of Employee Relations

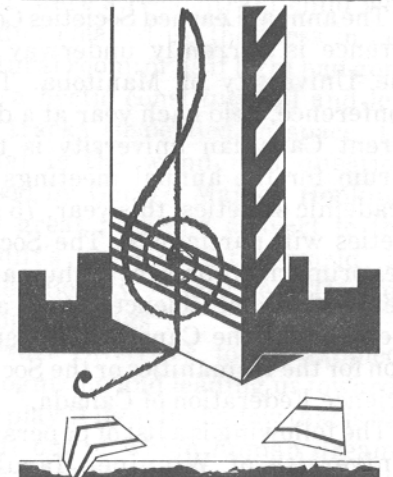
